#### A FEW GOOD MEN

eputy James D'Antonio from Santa Clarita Station started this chain reaction which resulted in a very respectful and dignified burial honoring one of our nation's heroes.

Deputy D'Antonio received a 927/3C "check the welfare" call while working patrol in Santa Clarita. When on scene, he learned that the resident, Charles "Corkey" James Corcoron, 78 years young, had passed of natural causes. "Corkey" was a Marine and clearly decorated at that as evidenced by a collection of Purple Heart ribbons Deputy D'Antonio saw nearby.

As the call unfolded, Deputy D'Antonio was able to contact the only family member he could determine, a sister in Iowa. Bonnie told Deputy D'Antonio that Corkey was in fact a recipient of not one but three Purple Hearts while he served in Korea. Sadly, Corkey also witnessed the untimely deaths of his friends while standing their ground in a conflict while serving there. She went on to tell that Mr. Corcoran was a good and decent man who had been confined to a wheelchair for the last 10 years of his life yet he never asked for anything. His sister, Bonnie, was very close to her brother. She adores the police and military but because she was unable to travel, was beside herself about what to do to honor her hero-brother. She told Deputy D'Antonio that Corkey's wishes were to be cremated and she wanted a Marine to help her.

Without hesitation Deputy D'Antonio offered whatever he could do to help fulfill her wishes and told her that he knew of a few good Marines, soldiers and deputies who would be honored to take part in laying Mr. Corcoran to rest properly. With that, Deputy D'Antonio began to solicit others to join him.

On Sunday, April 25, 2010, along with NCCF

Deputies and Marines Brian Reaves, Austin Embleton, Tim Lovitt, Ricardo Garcia-Toscano, NCCF Deputy and Soldier Ernie Baluyot, Court Services Deputy and Marine Joe Frey and Deputy D'Antonio bid farewell to Charles "Corkey" James Corcoran with the honor and dignity he deserved. Bonnie will be forever grateful for the thoughtfulness towards her brother, an American hero, who would have been delighted to know all of you who answered the call for help. Food-borne illness symptoms include: nausea, vomiting, diarrhea and fever. Should you experience these symptoms after eating a meal at home or away, notify your health-care provider immediately.

# VOLUNTEER METAL DETECTOR CRIME SCENE UNIT

old is not the only thing that the Volunteer Metal Detector Crime Scene Unit scans for in any area. This unit consists of approximately 30 volunteers who also search for metallic evidence associated with homicides, officer-involved shootings and other crime scenes using their metal detectors. They are members of the Prospectors' Club of Southern California which consists of over 200 members.



Over the years, Search Volunteers have been invaluable in locating critical evidence which was instrumental in solving major crimes. This unit is on call 24/7 and has worked hundreds of cases locating guns, knives, shell casings, live ammunition, all types of discarded weapons as well as narcotics, money and jewelry found in buried containers. They have searched for and located important evidence in officer involved shootings, homicides, narcotic cases and a variety of other crimes. In one Orange County case, Search Volunteers located gun parts that were thrown out over several miles of freeway after suspects disassembled and discarded parts of their weapons.

Although the Volunteers mainly conduct these services for the Los Angeles Sheriff's Department, they also perform these services for any law enforcement agency who requests it. They have provided volunteer services for the LAPD, FBI and 26 other law enforcement agencies in Southern California. They have received numerous acclamations for their services from several of these police agencies.

Their volunteer services are not limited to crime scenes. After recent major fires such as in the San Bernardino mountain communities and in the mobile home park in Sylmar, members of the Search Unit spent many days and hours sifting through ashes to help fire victims locate their valuables.

To perfect their special skills, Chief George Johnson, retired Navy, arranges for training at Rancho Los Amigos on a regular basis for this unit. They train in locating weapons and bullets that have been thrown in dense brush or that have been buried. They also train in avoiding and locating wired traps or explosives.



In addition to this training, Chief Johnson arranged for several speakers for the PCSC meetings. At the February PCSC meeting, Supervising Criminalist Ruben Flores, firearms expert at the LASD crime lab, spoke on various firearms topics that might aid the Search Unit in improving their skills.



One topic discussed by Gunnery Sergeant Tony Lino and his partners from Camp Pendelton was

Explosive Ordnance Disposal Teams in Iraq.

The Volunteer Search Unit can be requested by any law enforcement officer and will respond 24 hours a day, 7 days a week. Various members are located throughout Los Angeles County but can also respond outside of the County. Per very once in awhile, I hear Department members ask what they can do for members who are deployed to various countries with the military. Although it looks like the deployment for Iraq may be winding down over the next few years, it also looks like the deployment in Afghanistan is widening.

In talking with some of our Vets4Vets members, all of them said that while e-mails from home were appreciated, they might not get Internet access for sometimes weeks or months at a time. What was even more appreciated was an actual handwritten letter from someone "back in the world." A letter that either a family member or co-worker

who had taken the time to hand write and send out to them. A letter that they could not only actually hold in their hands, but that they could take with them and look over again at a later time. Photographs of current Department and family events are also much appreciated.

If you are going to send an e-mail to someone that is deployed, I would suggest not using their *LASD.org* e-mail address. Anyone who has not had access to their County e-mail account can attest that you will exceed your e-mail "account limit size" in a fairly short period of time, causing any further e-mails to be unsuccessfully delivered.

If you do not know who the deployed members are at your unit, or if you need an

address to send letters and/or care packages, contact your units' Military Liaison Officer (MLO) and they should be able to get you the required information.

If your unit does not have anyone currently deployed, you might consider checking with your assigned personnel and see if anyone has a family member that is deployed overseas. I am sure that they would greatly appreciate getting a card or care package from your UOA.

#### STRAIGHT UP

t's been a good night. You've been having a good time out with some buddies and coworkers eating, drinking and catching up. You know you've been tipping back a few, but figure you're okay to get home on your own; you've downed a lot more on other occasions without any problems. A friend or two ask if you want a ride, but you wave them off and split. Maybe your travels take you through the city, possibly a more rural, open area; either way, something happens and you get in a jam and the car is stuck on the side of the road. Or maybe you hit a pole, but in any event, the car is not going to budge - you're stuck. Now what? Don't want to call home and hear a lecture? And you really don't want to call one of the guys you were out with; you think they were truly messed up and you might get a lecture from one of them, too. You're in your station area and at least one of the new deputies recently off training should be in the field. And it so happens that you have their cell numbers in your phone. So you try one, luck out on the first try, getting the one on duty and roll him your way.

After he shows up, you notice he's giving you a concerned look and seems hesitant, but he's still on probation and so he does what you ask; he's still in awe of the three stripes on your sleeves. While you sit and stare at your car and ponder what this might cost, your subordinate is in the R/C on the phone. You figure he's calling for a 926, but after the W/C rolls up you feel as if someone turned up the heat. The lieutenant asks about how your night's been going, before your attempt at off-roading, including if you remember how much you've had to drink. Then the other shoe drops and he tells you he wants you to blow, and he doesn't mean leave the area. Pretty soon you're at the station staring at the numbers showing on the machine, cursing your car, the pole, the ditch, whatever brought you to this point. You forgot to curse your stubbornness

and your lapse in judgment — it was your decision to drive and not look at other options.

What else might be a problem here? While you didn't order anyone to help you, it's implied because of your standing. Did the deputy do the right thing by informing your superior? I base this on a real incident occurring in Washington at the end of March, as reported in The Seattle Times. A State Patrol trooper, with just 14 months on the job, was called by his sergeant requesting his help during the early morning hours. The sergeant, with the WSP for 21 years, had somehow driven off the road and gotten stuck. When the new trooper arrived, he noted signs of intoxication, believed the sergeant was impaired and made the call. The lieutenant and another sergeant rolled, administered FSTs (which didn't go well) and the sergeant was hooked for DUI. All these circs could have been avoided, even if a call was made by sarge to the trooper before getting into the car. Using the taxpayers' dollars to get a ride home is not the best thing to do, but wiser and cheaper in the long run. The sergeant was placed on "paid administrative leave," which means he gets paid to sit at home and reflect on the past 21 years of his career and wonder what's around the corner.

What else did he do? He really put the pressure on the trooper, probably without any malicious intent. But by calling him for help, it put the new guy in a Catch-22 situation. The trooper, believing he needed to help his superior, responded when called. When he formed the opinion the sergeant was impaired, he was caught between helping get the car unstuck, thereby possibly allowing an intoxicated driver back on the road, or refusing to help and then possibly suffering an unofficial "charge" of insubordination or some other fate. The option he chose, whether you agree with it or not, was based on his ethics, morals and maybe training in integrity and honesty. Of course, he could have just called for a tow and been done with it all. Maybe this sergeant has some issues with the bottle and needed a wakeup call. If it were you, whether supervisor or subordinate, what would you do? If you're having trouble making some decisions of your own regarding your drinking, call Employee Support Services Bureau and speak confidentially with me or a Law Enforcement Psychologist. There are also Peer Support members and chaplains throughout the Department available to help. Be seeing you. ☆

## FROM THE DOCS

#### **WARRIOR SPIRIT AT HOME**

ur Sheriff's Department has more than 500 reservists, many of them being deployed to the most dangerous military operations in Iraq and Afghanistan. When they receive their military orders to deploy to the "sandbox," they often have to immediately drop their current life and postpone their goals. They feel the stir of mixed emotions of sadness and excitement as they say their good-byes to loved ones. They also feel pride and a sense of duty to serve and protect our country. Ironically, they are very familiar with the warrior spirit to fight against the enemy on our streets or in foreign countries, but most of them will struggle to "fight" to rejoin and reconnect with their loved ones when they return home.

Our Department vets have the most dangerous jobs in our current war since they are frequently infantry soldiers or military police. They are often on convoys for days under constant threat of improvised explosive devices (IED) on the road and are interacting closely with foreign nationals in very chaotic situations. Their family members are also aware that their work is "outside of the wire." They struggle every day to believe their loved ones are safe and will return home unharmed. It takes tremendous strength to have this kind of faith. Most of the soldiers agree that the sacrifices made by their family members are sometimes greater than their contribution to their military deployment. However, most soldiers and their family members will tell you that the reunions are often awkward and disappointing.

During the Bosnian conflict in the late '90s, I was deployed as a mental health officer in the Army. I experienced firsthand the strength and power of a soldier's heart. I am referring to the "warrior spirit" which often is equated to dedica-

tion of mission, honor and duty. Their life is not about what they can get but what they can do and give. After counseling many of these soldiers, I quickly realized that their strength is fueled by the ones that love them. This is why I am extremely disturbed to learn about the high rate of family conflicts and divorce among currently deployed military service members. According to the Pentagon research, the divorce rate increased 78 percent from 2003 to 2004 among military officers. The divorce rate among the enlisted is predicted to be significantly higher. Other research demonstrates that the divorce rate for veterans may be 62 percent higher when compared to the rate among civilians. The stress of deployment on family relationships is a major concern for all military branches since the leaders in the military are keenly aware that family support keeps soldiers strong and focused. During deployments, soldiers learn how to survive and succeed in a war setting. One of those skills is their ability to be secretive and impassive; emotional/behavioral control is an important survival strategy when there is a constant threat of injury or death. However, this survival strategy is exactly the opposite of what is needed to have a close relationship with your loved ones. Open communication and sharing feelings are essential to build and maintain healthy levels of trust, respect and intimacy. In sum, the survival strategies used during deployments become obstacles to establishing close relationships at home. Common complaints by spouses of soldiers after they return home are, "I don't know him/her anymore," "he/she is back but I am still alone" and "he/she is always angry."

Some of the ways to rebuild that bond with your "battle buddy" in your life is to work together and to put that "warrior spirit" in your everyday life: As I

mentioned before, apply the dedication of mission, honor and duty in your relationships. First step is to become more aware of the negative consequences of your natural "military trained" tendencies. Next is to make a committed decision to change your "automatic" reactions. And the most important step is to learn how to execute new ways to interact with your loved ones. Some of the ways to rebuild that bond is to become more compassionate, establish safety with each other, identify and respond to your buddy's needs, offer useful assistance and share coping skills. This means that you will have to take some risks, be willing to be emotionally vulnerable to your loved ones (remember that they are not your enemy), accept differences and be willing to challenge your old perceptions and ideas. In addition, avoid negative communication habits such as being critical and judgmental, telling them what to do and interrogating your partner when all they need is for you to listen and indicate that you understand. Even with good intentions, we can be caught in this vicious cycle of being a poor communicator. Again, fight for your relationships with similar mission, honor and duty as you did in the combat zone.

It may be true that your relationship was changed forever by what you experienced in the war, but your new mission is to make it better than it was before. #### **CHOOSING TO COPE OR TO LIVE**

e work in a world of extremes. So much so that we are sometimes genuinely surprised, albeit rare, by a day when nothing happens. We need those days. The reality of this job, however, is that it can be stressful, very stressful. Not just for those in the field. How you deal with that stress can determine your ability to cope as well as your longevity. It is interesting how many of us have said that our goal is to make it home. Very few of us have ever said we want to finish well. The first has a forward-looking vision of 10 hours, the latter looks to the life we will have beyond the career.

If you think about stress management in terms of coping (short term) and longevity (long term), certain important factors become apparent. If you are trying to "cope," you can deal with the temporary effects of stress in harmful ways. If you are looking to last, stress must be handled in

productive ways. We must make every effort to deal with our stressors in a way that both helps us cope and builds strength, health and longevity.

Here's what I mean: Look at the coping factors. Each of them might help you deal with the stresses in the immediate, but will have a detrimental effect on the long term.

Short-term harmful coping mechanisms may include: overeating (or non-nutritional), alcohol, smoking, extreme activities or other forms of binging. These will help you cope, but they will not help you finish well. Consider dealing with stress in positive ways that do both: help you cope and help you last.

Long-term helpful coping mechanisms may include: healthy eating, exercise, prayer and meditation, a hobby and music. I know one individual that began attending religious services with his wife. He had always thought, "That's her thing," but soon realized that the comfort, life truths and family unity that he found there did more to curtail his stress than any prior practice. Besides, he became a better person.

Why settle for something to get you through a day when you have the ability to choose something that will get you through life?

As I write, I think of a starving man, frustrated by the fact that he has been living at the side of a lake full of fish but has failed to catch a single one. He is nearly dead from starvation. Meanwhile, a man approaches offering him either a fish, or a fishing pole. With the desperation that only a starving man could understand, he chooses the fish.

HINT: Choose the pole!



#### GOOD OLD DAYS?

Consider the following office rules, posted in this country in 1872 by Zachary U. Geiger, sole proprietor of the Mount Cory Carriage and Wagon Works.

- 1. Office employees will daily sweep the floors, dust the furniture, shelves and showcases.
- Each clerk will bring in a bucket of water and a scuttle of coal for the day's business.
- Clerks will each day fill lamps, clean chimneys, trim wicks. Wash the windows once a week.
- Make your pens carefully. You may whittle nibs to your individual taste.
- 5. This office will open at 7 a.m. and close at 8 p.m. daily, except on the Sabbath, on which day it will remain closed.
- 6. Men employees will be given an evening off each week for courting purposes, or two evenings a week if they go regularly to church.
- Every employee should lay aside from each pay a goodly sum of his earnings for his benefits during his declining years, so that he will not become a burden upon the charity of his betters.
- Any employee who smokes Spanish cigars, uses liquor in any form, gets shaved at a barber shop, or frequents pool or public halls, will give me good reason to sus-pect his worth, intentions, integrity, and honesty.
- 9. The employee who has performed his labors faithfully and without fault for a period of five years in my service, and who has been thrifty and attentive to his religious duties, is looked upon by his fellowmen as a substantial and law abiding citizen, will be given an increase of five cents per day in his pay, providing a just return in profits from the business permits it.
